

Terms and Conditions

Applicable Terms

- All bookings made by any firm, company, group, individual of whatever type (“The Guest”) are subject to these terms and conditions.
- They are to protect all parties avoiding any misunderstanding when confirming a reservation and apply to all Golf Days booked with Bicester Country Club.

Confirmation by The Guest

- All bookings are considered provisional and will not constitute a legal contract until it has been confirmed in writing by both The Guest and Bicester Country Club and until any deposit or payment in advance of any changes requested by Bicester Country club has been made and a receipt sent to the Guest.
- Unconfirmed bookings are not guaranteed.

Written confirmation must detail the following:

- Name of person accepting full responsibility of the booking.
- Name of person accepting full responsibility on the occasion of the event if different to the above.
- Full address, post code, two contact numbers for the above named persons.
- Date of function, approximate number of guests, time of function and an indication of catering requirements.
- Completion of the Acceptance Form of these Terms and Conditions.

N.B. A more accurate estimate of numbers, timings, menus and any special requests, should be given 4 weeks prior to the function and the final numbers 7 days in advance—this is the minimum we will charge for.

Terms of Payment

- A deposit of £100.00 will be required to confirm the booking as soon as possible after a provisional booking has been made and is non refundable. Please make cheques payable to Bicester Country Club (non members) Ltd
- All provisional bookings will be held for 28 days and maybe released unless written confirmation and a deposit has been received.
- Payment is due 7 Days prior to the day if paying by cheque or prior to commencement of play on the day if paying by Credit Card or Cash.

Corkage

- We do not permit guests to supply their own wines or spirits.

Damage

- The guest shall be responsible for any damage caused to the allocated rooms, grounds of furnishings, utensils and equipment therein by an act, default or neglect of the guest, sub-contractors or guests attending the function and shall pay Bicester Country Club on request, the amount required to make good or remedy such action.
- The Guest shall not affix any materials to walls or ceiling of the premises by the use of nails, screws, pins or any adhesive tape of any kind without the prior consent from Bicester Country Club.

Conduct

- The Guest shall take full responsibility for the orderly conduct of the function guests, to ensure that nothing will be performed which constitutes a breach of the law, the safety and well being of the staff engaged for the duty, the security of the venue and or in any way cause a nuisance of infringe any licensing laws, illegal gaming or betting laws.

Amendments

- Amendments to numbers and/ or arrangements must be confirmed to Bicester Country Club in writing.
- No charges will be made for any reduction in numbers of less than 10% of the total given 7 days prior to the arrival provided they are given in writing.
- Cancellation Charges—Organisers must give 4 weeks’ notice in writing to cancel a function. Failure to meet this requirement will result in a charge being made for the numbers previously given.

Pricing

- All prices are liable to fluctuate and prices will only be guaranteed for 6 months prior to functions.
- All prices are subject to government changes on taxation, even if the booking is confirmed in writing.
